

Terms and Conditions ("Terms")

Please read these Terms and Conditions ("Terms", "Terms and Conditions") carefully before using the Ausigned contract management service and the Ausigned mobile application (the "Service") operated by Ausigned ("us", "we", or "our").

Your access to and use of the Service is conditioned on your acceptance of and compliance with these Terms. These Terms apply to all visitors, users and others who access or use the Service.

By accessing or using the Service you agree to be bound by these Terms. If you disagree with any part of the terms then you may not access the Service.

You must be at least 18 years of age to use the Service. By using the Service and by agreeing to these terms and conditions you warrant and represent that you are at least 18 years of age.

This Service uses cookies. By using the Service and agreeing to these terms and conditions, you consent to our use of cookies in accordance with the terms of our privacy policy.

Governing Law.

The Service, including contracts concluded in the Ausigned system and subsequent digital signatures created on the Ausigned system will be deemed, for legal purposes, to have taken place within the Commonwealth of Australia.
